2. Applicability and Prices

- a) These general conditions are applicable on all offers and all orders made on or through the webshop 'SHOP' of website www.tinewilde.com
- b) The offers on the website are made without obligation and while stock lasts.
- c) TINE WILDE is not bound by evident mistakes or errors in the offers and descriptions on the website. Please note that the colours and reproduction of pictures in print can differ a little bit from what you see on your screen.
- d) All prints are accompanied by a signed, numbered and dated Certificate of Authenticity.
- e) All prices include VAT and free shipping within the Netherlands unless otherwise stated.
- f) You must be 16 years of age or older to order from the webshop and by accepting these terms and conditions you are confirming this.
- g) All prices may be subject to change. Prices for specific works may rise as an edition begins to sell out.
- h) The description and price of the fine art photo prints will be as shown on the webshop at the time you place your order. Every effort will be made to ensure that prices shown on the webshop are accurate at the time of purchase. If an error is discovered prior to dispatch of your order, TINE WILDE will inform you as soon as possible and offer you the option of reconfirming your order at the correct price or canceling your order.
- i) When ordering online, your order will be sent with a filled out order form to TINE WILDE by email. You will also receive an email confirmation that TINE WILDE has received your order. Should you not receive an email, please contact TINE WILDE by email.
- j) All prints are subject to availability. If on receipt of your order the prints are sold out, TINE WILDE will inform you and refund or re-credit you for any sum that has been paid by you for the unavailable prints.
- k) TINE WILDE is under no obligation to accept any order.

3. Delivery

- a) The prints you order on or through the webshop of the website www.tinewilde.com are printed, packed and shipped by a professional photo lab, i.e., Fotolab Amsterdam www.fotolab.nl.
- b) Fotolab Amsterdam will deliver a maximum of three items in the same packing. More than three items from the same order will be charged separately.
- c) Prints ordered will be delivered to the address stated on the order form.
- d) The order will be sent to you by post. TINE WILDE will endeavour to deliver prints within The Netherlands within 14 days of receipt of payment unless otherwise stated on the website. Outside The Netherlands, delivery depends on the mail company and the country the package is sent to. Delivery outside The Netherlands comes with additional costs.
- e) Delivery of prints to you will be considered to have occurred once the package is placed with the mail, or any other service we may use.
- f) If there is no one present at the delivery address to accept delivery, you will be offered an alternative delivery date or place to collect the prints. Registered mail cannot accept responsibility for goods that are returned to the post office and remain uncollected.

- g) Once a package is considered delivered, responsibility for the package, risk of damage or loss will pass to you and you shall be responsible for insuring the work.
- h) If TINE WILDE is unable to deliver your order within 30 days the package will be sent back to the sender Fotolab Amsterdam. It can be resend to you at additional cost.
- i) TINE WILDE is not liable for any loss or damage suffered by you through any unavoidable delay in delivery of an order.
- j) TINE WILDE is not liable for any damage which occurs to an order after a delivery has been made.

4. Right of return

- a) In case of ordering products via the webshop of the website you have the right to return the products received without specifying any reasons within 14 days of receipt. During this period you will have to treat the product with care. If you want to exercise your right of return, you will have to send the product in the original state and properly packed back to the sender: Fotolab Amsterdam, together with the Standard Form for Withdrawal and the Certificate of Authenticity that comes with the product.
- b) If you exercise your right of return you shall bear the direct costs for returning the product.
- c) After receipt of the product, the purchase amount will be paid back to you within 14 days, unless the product is damaged, in which case the decrease in value of the product will be deducted from the purchase amount.
- d) The right of return can not be invoked in case a personal message was written in or applied on the product or in case a product is otherwise personalised for you.
- e) TINE WILDE accept no responsibility for products damaged or lost in transit.

5. Complaints procedure

- a) TINE WILDE shall have a sufficiently notified complaints procedure in place, and shall handle the complaint in accordance with this complaint procedure.
- b) Complaints about the performance of the contract shall be submitted fully and clearly described to TINE WILDE within a reasonable time after you discovered the defects through the Form for Complaints.
- c) The complaints submitted to TINE WILDE shall be replied within a period of 14 days after the date of receipt. Should a complaint require a foreseeable longer time for handling, TINE WILDE shall respond within 14 days with a notice of receipt and an indication when you can expect a more detailed reply.

- b) The Artist's Resale Right entitles TINE WILDE to 4% of the proceeds when the work is resold for at least € 1000,00 by an auctioneer or dealer.

7. Privacy
